The unexpected COVID-19 school closure took many people by surprise. However, it was also an unanticipated opportunity to be creative with learning. Many students still struggled even though the teachers were creative and supportive. Some student made solid progress but others fell farther behind.

Student learning gaps were a foreseeable challenge, as the governor closed schools in NYS. To help mitigate this challenge, CMCCS is using a multisensory approach to reading through Preventing Academic Failure, PAF, in all grades. PAF supplements Engage NY; it does not replace it.

Students who need smaller group instruction will be able to do so in person or in a virtual space because we typically have two teachers and a teaching assistant in every classroom. We have a mini lesson and three breakout groups. We are also purchasing each student a computer and hotspots as needed to make the most of any virtual time learning. Testing students math skills and reading abilities a couple of times per year will allow us to see student progress. This knowledge will let us know about the student's learning style. This will allow us to find and assist struggling students.
